

Launchpoint Caroline Award

Notes to applicants:

- a) Please ensure that you take care completing this application. If you feel something doesn't apply to you, please say why, rather than leaving a blank space.
- b) To apply, you must be an active member of a British Gliding Association gliding club ideally for a period of at least 3 Months.
- c) You need to provide a photocopy of the latest page of your pilot logbook **and** evidence of sign-off for ground duties.
- d) When you have completed sections 1 & 2, take your completed application to the Chief Flying Instructor of your gliding club or their nominee and ask them to complete section 3.
- e) You should submit the completed application form and all other relevant documents by post or email (details below).
- f) Note that vouchers will have an expiry date. (stated on the voucher). Please ensure that you use the vouchers before this date.
- g) A condition of the grant is that, once you've used it, you provide Launchpoint with a short written piece (no more than 200 words), telling us how the award has helped your flying. Please also include a photograph and send to Launchpoint at carolineawards@launchpoint.org.uk. This information may be used on social media, in direct contact with interested parties, and/or in presentations and conferences. The purpose is to raise awareness of the work the charity is doing and for fundraising activities.
 - Please note that in applying for a grant, you are agreeing to the terms and conditions at https://members.gliding.co.uk/library/ct/caroline-trust-terms-and-conditions/ and giving permission for your image to be used if you receive a grant.
- h) All personal data gathered in this form will be managed as stated within Launchpoint's GDPR policy, a copy of which is available on request. Data is kept for the purpose of maintaining contact to support further fundraising.
- i) If you are actively using another award for gliding or power flying, you will not be eligible for a Caroline Award until that grant has been spent.
- j) We ask all recipients to consider becoming an 'ambassador' for Launchpoint within their club. This would entail promoting the charity, arranging fundraising events and keeping the club up to date on Launchpoint's activities.
