**THE AIR NAVIGATION (RESTRICTION OF FLYING) (BALMORAL) (RESTRICTED
ZONE EG R704) REGULATIONS 2019**

PERMISSION

1. The Police Scotland Royalty and VIP Planning (North), in exercise of its powers under Regulation 2 of The Air Navigation (Restriction of Flying) (Balmoral) (Restricted Zone EG R704) Regulations 2019, hereby permits any glider to fly in the Balmoral area as specified by Regulation 2 of the said Regulations.
2. This Exemption is granted subject to the following conditions:
 - (a) no flight shall be made pursuant to this Permission in a glider with a glide angle of less than 1 in 30;
 - (b) no flight shall be made pursuant to this Permission below 500 feet above ground level within 600 metres of:
 - a. Balmoral Castle (570227N 0031349W) as depicted in charts 1 and 2; and
 - b. Craigowan House (570152N 0031303W) as depicted in charts 1 and 2.
 - (c) no photographs of the locations concerned shall be taken while flying pursuant to this Permission; and

- (d) no flight shall take place at night.
3. The Permission shall have effect from 15 May 2024 to 14 May 2025 both dates inclusive, unless previously revoked.

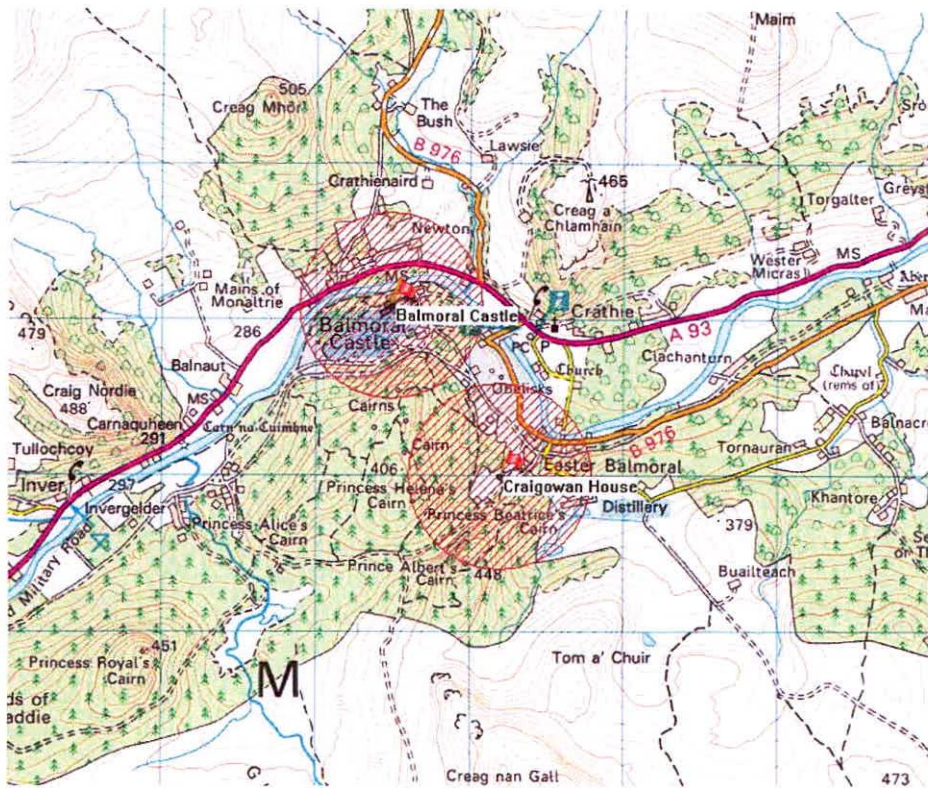

**THE AIR NAVIGATION (RESTRICTION OF FLYING) (BIRKHALL) (RESTRICTED
ZONE EG R705) REGULATIONS 2019**

PERMISSION

1. The Police Scotland Royalty and VIP Planning North Unit, in exercise of its powers under Regulation 2 of The Air Navigation (Restriction of Flying) (Birkhall) (Restricted Zone EG R705) Regulations 2019, hereby permits any glider to fly in the Birkhall area as specified by Regulation 2 of the said Regulations.
2. This Exemption is granted subject to the following conditions:
 - (a) no flight shall be made pursuant to this Permission in a glider with a glide angle of less than 1 in 30;
 - (b) no flight shall be made pursuant to this Permission below 500 feet above ground level within 600 metres of Birkhall House (570144N 0030427W) as depicted in charts 1 and 2;
 - (c) no photographs of the locations concerned shall be taken while flying pursuant to this Permission; and
 - (d) no flight shall take place at night.
3. The Permission shall have effect from 15 May 2024 to 14 May 2025 both dates inclusive, unless previously revoked.

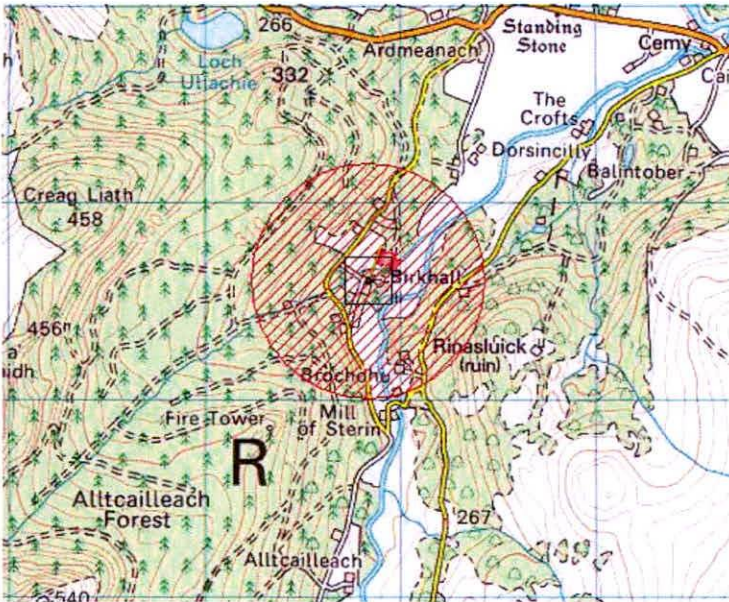
